10. **PROVISION OF SAMPLES:** The vendor shall present a sample box containing all items to NDMA.

11. **Earnest Money:** The Firms are required to submit **Earnest Money @ 2% of the bid value** in the name of Director (Procurement), NDMA. However, the same will be returned in case of rejection.
12. **Draft Contract Agreement:** Draft contract agreement as per appendix - B
13. **Award of Contract / Supply Order:** Competitive bidding will be done through Single Stage One Envelop System as per PPRA Rules. The firm offering overall lowest bid against items of required quantity and specifications will be awarded the Contract / Supply Order.  
**Maximum Time of Delivery:** The selected firms would be liable to deliver their respective items within the stipulated time period, otherwise Late Delivery Charges to the tune of 0.5% to be imposed on daily basis.
14. **Payments:** Payment will be processed after satisfactory delivery of the required items as per supply contract / agreement.
