The firms must be registered with Income Tax and Sales Tax Departments. The interested firms should be technically as well as financially sound. The firms must have the capacity to deliver the aircrafts within 15 x days' time after signing of hiring agreement. 10. **Specification / Conditions:**

- a. Agriculture aircrafts, fitted with **spraying kits** for anti-Locust spray. Preferably turboprop engine.
- b. Should be able to spray anti-locust pesticide over affected areas.
- c. Minimum range 1200 km and endurance 6 hours (for operations in Balochistan and far-flung areas). More range and endurance shall be preferred.
- d. Short take-off and landing capability.
- e. Long range radio communication and good navigation aids.
- f. ADSB preferred.
- g. Minimum logistic support requirements during shifting of locations.
- h. Availability and operationalization in earliest time frame.

- i. Supplier should have the necessary license / NOCs from CAA and all concerned government agencies.
  - j. Supplier shall quote its **cost of hiring** of aircrafts in terms of **Pakistani Rupees / US Dollars per hectares** of area sprayed.
  - k. Pilots, crew, fuel, maintenance and all other **operational / logistic arrangement** shall be made by **supplier**.
  - l. NDMA / Department of Plant Protection shall provide the **pesticide** for the spray.
  - m. Any advance shall be paid on deposit of **bank guarantee and performance bond** by the **supplier**.
11. **Earnest Money:** The Firms are required to submit Earnest Money @ 2% of their respective bid value in the name of Director (Procurement), NDMA. However, the same will be returned in case of rejection.
12. **Award of Contract / Supply Order:** Competitive bidding will be done through Single Stage One Envelop System as per PPRA Rules. The firm offering overall lowest bid, with minimum delivery time, against items of required quantity and specifications will be awarded the Contract / Supply Order.
13. **Maximum Time of Delivery:** The selected firms would be liable to deliver their respective items within the stipulated time period (not more than 15 days).
14. **Payments:** Payment will be processed after satisfactory delivery of the required items as per supply contract / agreement.
